## ANNEXURE-A

### A scheme for engagement of Para Fitters and Para Pump Operators and Multipurpose Workers for operation and maintenance of Water Supply and Irrigation Schemes in IPH Department for the year 2020

To strengthen the service delivery mechanism in rural water sector and Irrigation schemes in the State, it is proposed to engage 704 skilled persons to be known as Para Fitters (287 posts) and Para Pump Operators (417 posts) depending upon the trade certificate possessed by the incumbent and 874 Multipurpose Workers.

The incumbent is to be selected/appointed by the Committee constituted for the purpose. <https://gyananetra.com/>

- a. The person selected may suitably be designated as **Para Fitter/Para Pump Operator/Multipurpose Workers**.
- b. These incumbents would be placed depending on objective criteria of requirement.
- c. **These incumbents would be deployed on 394 new drinking water and irrigation schemes and IPH Department would ensure commissioning and accrue benefit for the people from these schemes.**

#### **Eligibility and Educational Qualification criteria for Para Fitter/Para Pump Operator/ Multipurpose Workers.**

##### **Para Fitter**

The candidate should have a minimum qualification of Matriculation (10<sup>TH</sup>) with ITI certificate in the trade of fitter from a recognized ITI.  
OR Matriculation (10<sup>th</sup>) with certificate in above cited trade under Skill Development Scheme of the Government.

##### **a. Para Pump Operator**

The candidate should have a minimum qualification of Matriculation (10<sup>th</sup>) with certificate in trade of electrician/wireman/diesel mechanic/pump mechanic/motor mechanic/pump operator cum mechanic from a recognized ITI OR Matriculation (10<sup>th</sup>) with certificate in above cited trades under Skill Development Scheme of the Government.

##### **b. Multipurpose Workers**

The candidate should have a minimum qualification of Middle pass and its equivalent from School duly recognized by the State Government.

For these categories minimum age for application shall be 18 and maximum shall be 45 years. Knowledge of custom, manners and dialects of Himachal Pradesh is desirable.

#### **Method of engagement of Para Fitter/Para Pump Operator/ Multipurpose Workers**

- i. Appointing authority shall be the Executive Engineer concerned.
- ii. The incumbent is to be appointed after selection by the committee constituted for the purpose.
- iii. Weightage shall be given to the bonafide and experience in relation to the post applied.
